#### 7. CONCLUSIONS

During the study a drop-out case occurred for reasons not correlated with the test, therefore the conclusions are referred to 19 volunteers.

The occlusive application of the tested product for 30 minutes  $(T_1)$  on 19 healthy subjects, did not induce any reaction related to an Immediate Skin Irritation Potential.

The occlusive application of the tested product for 48 hours, on 19 healthy subjects, did not induce any reaction related to a Skin Irritation Potential, as assessed at the occlusion removal ( $T_2$ ) and 24 hours after the product removal ( $T_3$ ).

No allergic reaction was observed.
